- New arrangements started on 1 February 2021
- Expanded scope of screening includes mandatory and optional screening
- Stronger safeguards for people with disability
- Streamlined systems and processes
- National NDIS clearances are portable across Australia

- Stronger safeguards:
 - online ID check
 - 'no card, no start' approach
 - more offences disqualify a person
 - test: whether person poses an unacceptable risk of harm to people with disability
 - ongoing national monitoring of NDIS worker screening applicants and clearance holders

- Streamlined systems
 - online application system
 - NDIS clearances valid for 5 years instead of 3 years
 - checks portable across Australia
 - integration with NDIS Worker Screening Database

- NDIS Commission responsible for NDIS providers
- NDIS Commission owns the NDIS Worker Screening Database (NWSD)
- Qld government responsible for screening workers
- Qld government owns the new Worker Portal access from our new website

Self-managed and plan-managed participants

- If you want your workers screened you can request access to NDIS Worker Screening Database (NWSD)
- When the NDIS Commission gives you access, you will get a SMP ID number – you can give this ID number to your workers if you want them screened
- Then ask your worker to apply for a NDIS Worker Screening Clearance through our portal
- They will select you as their employer using your SMP ID number

Self-managed and plan-managed participants

- Workers can apply online on the Worker Screening website
- If they can't apply online, we can help
- You will get an email from the NDIS Commission when worker has submitted application
- You have 30 days to log in to NSWD and verify the worker's application
- Their clearance to work cannot be processed until you verify them
- When outcome is available, you will get another email from the NDIS Commission

Cost of worker screening

- NDIS Worker Screening Clearance (paid workers) \$117
- NDIS Worker Screening Clearance (volunteers) free
- NDIS Worker Screening and WWCC Blue Card (paid workers) \$127
- NDIS Worker Screening (volunteer workers) and WWCC Blue Card (paid workers) - \$10
